

Bylaw 2018-03

Environmental Services Bylaw

A bylaw of the Town of Eston, in the province of Saskatchewan, under the authority of Sections 285, 298, and 290 of *The Municipalities Act*, for the purposes of establishing fees for the collection and disposal of solid waste and recycling, and for landfill operations, known in combination as environmental services.

The Council for the Town of Eston in the Province of Saskatchewan enacts bylaw 2018-03 as follows:

1) Short Title

a) This bylaw may be cited as the Environmental Services Bylaw.

2) Definitions

- a) "Charge" means a fee or rate payable for environmental services.
- b) "Commercial Premises" means a unit or units constructed to conduct manufacturing, wholesale, retail, or service trade.
- c) "Institutional Premises" means a unit or units based primarily to provide public services, including but not limited to schools, hospitals, Senior Care Homes, and local, provincial and federal government buildings.
- d) "Recycling" means the recyclable products currently being accepted within the curb side recycling pickup program or at another recycling outlet in the Province of Saskatchewan.
- e) "Residential Premises" means a unit or units constructed for habitation by one or more people and includes any of:
 - i) A single detached building
 - ii) A duplex building
 - iii) A multiple unit dwelling
 - iv) An apartment dwelling
 - v) A mobile home dwelling
- f) "Town" means the Town of Eston, in the Province of Saskatchewan.
- g) "Unit" means a building or portion of a building where a water service connection has been installed. Each water service connection shall constitute one unit.
- h) "Waste" means bagged, boxed, or any refuse that cannot be recycled which is set out for collection and disposal in the Town of Eston Landfill.

3) Waste and Recycling Collection Services

- a) Waste and recycling collection service shall only be provided to occupied units which have an active utility account.
- b) Residents are to provide their own waste collection bags or bins.
- c) Residential and commercial premises shall be provided with one roll out bin for recycling for each unit. Should commercial recycling volumes exceed that of the roll out bin, the business is to rent the appropriate sized recycling bin directly from the service provider.

4) Service Charges

- a) The Town shall charge the owner or occupant of all premises monthly fees for environmental services according to the rates set out in Schedule A attached to and forming part of this bylaw.
- b) Charges shall be billed to the owner or occupant on each utility bill.

5) Penalties

- a) Charges remaining unpaid thirty (30) days after the billing period shall be assessed a penalty of two percent (2%) and an additional two percent (2%) compounded each month thereafter until the arrears are paid.
- b) Any charges including penalties that are sixty (60) days in arrears and greater than \$200 on December 31st of the year in which they were payable shall be added to and thereby form part of the taxes for that property.

6) Repeal and Coming Into Force

a) Bylaws 2-94 and 6-2014 are hereby repealed.

b) This bylaw shall come into force on June 1, 2018

Schedule A Waste Collection Service Charges

Classification	Charge
Residential, Commercial and Institutional (unless otherwise specified below)	\$25 per month
Additional Roll Out Recycling Bin	\$5 per month
Multi Unit Residential, Restaurants and Commercial Up to and including 20 Units (i.e. motels and apartments)	\$65 per month
Multi Unit Residential and Commercial Over 20 Units (i.e. motels and apartments)	\$115 per month
Special Care Home	\$260 per month
